Dear Law Enforcement:

The recent politically motivated indictments against President Trump, contrasted by the insulting, disgraceful deals to the Biden family for their crimes and corruption, have illuminated the fact that we are no longer a nation governed by laws and anchored by our Constitution. Our great Union has devolved into selective persecution, abusing political processes, and weaponizing statutes for the purpose of bogging down or eliminating a political foe by lawfare. This anti-constitutional, Marxist tyranny must be stopped.

The Biden administration has fully weaponized the DOJ and deployed lawfare tactics designed to weigh their political opponents down in the quagmires of our legal systems with overblown and/or baseless charges, endless depositions, and countless motions. This exorbitant number of legal filings by the Biden regime are not in pursuit of public justice; but intimidation and harassment tactics generating tremendous amounts of paperwork and expenses that are forcing victims to drain their savings, sell their homes, and in some cases leading to bankruptcy.

Unfortunately, these endless Soviet-style persecutions will not be stopped by our Representatives in D.C. This new level of corrupt legal warfare must be answered on a state and local level by going after the real, plentiful, and widespread corruption being revealed by the day. It will take brave Attorney Generals, Sheriffs, Inspectors General, and other members of law enforcement to do it.

While the regime continues to harass President Trump, evidence revealing that the Biden family has been selling Joe Biden's positions as Senator, Vice-President and now President continues to surface. This evidence shows the Bidens have been, and continue to, enrich themselves through unethical and illegal business deals, often at the cost of America's best interest.

While we don't engage in conspiracies, we also believe there are no coincidences. The charges brought against President Trump were announced the same day as it was revealed that the FBI has suppressed evidence from the American public that show Joe Biden took (at least) a \$5 million bribe from Ukraine on behalf of oil & gas company Burisma, where his son Hunter was given a seat on their board.

Oil & gas is the lifeblood of our economy, but unfortunately it also seems to be the <u>Bidens' industry of choice</u><sup>[1]</sup>. The Bidens have pursued multiple high-level oil and gas business dealings in the state of Louisiana, and due to the recent public disclosures of potential bribery, these transactions must be scrutinized.

All Biden family business dealings executed in the state of Louisiana must be reviewed to ensure no violations of Louisiana laws concerning bribery, corruption, or foreign investments took place. A good starting point would be to review the Hunter Biden laptop via the <u>Biden laptop search tool here</u><sup>[2]</sup>. The Marco Polo laptop report details over 450 Federal crimes the Bidens committed during their decades selling power and influence. How many Louisiana laws were also broken?

You should reach out to Tony Bobulinski, a whistleblower on Biden corruption who has spoken out publicly about Biden dealings, including with the CCP via CEFC China Energy.

The House Oversight committee has also developed a list of persons and businesses<sup>[3]</sup> that may be involved in corruption.

## Louisiana LNG

Page 125 of the <u>Biden Laptop Report</u><sup>[4]</sup> shows Biden-connected businesses were working with CEFC China Energy to secure a deal related to the Monkey Island LNG facility in Cameron Parish.

Devon Archer, a business partner of Hunter Biden at Rosemont Seneca and Hudson West III, as well as Ukrainian Vadym Pozharsky, a member of Burisma's board (and also involved in dealings with the CCP<sup>[5]</sup>), were both presenters at a 2015 LAGCOE<sup>[6]</sup> (Louisiana Gulf Coast Oil Exposition) event.

In 2017/2018 <u>Hudson West III identified LNG projects</u><sup>[7]</sup> to be involved in including Monkey Island LNG, Magnolia LNG terminal, Port Cameron, and various trading deals. Hudson West III (and other shells) were used to facilitate deals for the Bidens, including those involving CEFC, a CCP controlled energy company. The <u>Monkey Island project</u><sup>[8]</sup> was a focus of the Bidens, as well as <u>multiple sales of LNG</u><sup>[9]</sup>, some to <u>Chinese firms</u><sup>[10]</sup>.

## Election Dark Money – "Zuckerbucks"

Also connected to Monkey Island are groups who were <u>under investigation for using Zuckerbucks</u><sup>[11]</sup> in the 2020 election. Some under investigation for using Zuckerbucks in Louisiana in 2020, are part of the <u>PR team on the Monkey Island</u> <u>project</u><sup>[12]</sup>. Other connected entities are Arabella Advisors, <u>Center for Technology and Civic Life (CTCL)</u><sup>[13]</sup> and New Venture Fund. Zuckerbucks money went almost exclusively to benefit Democrats in 2020 and was funding the areas around the country whose election results were beyond questionable. If Zuckerbucks dark money was involved in our state in 2020, the DNC and Biden campaign would be the primary beneficiaries. Did any of that money go to local mayoral or DA races?

#### Trafficking of Illegals and Minors Through Louisiana

The Biden administration is engaged in the largest human trafficking operation ever. They are finishing the job of the cartels and smugglers <u>by transporting illegals</u>, <u>including children</u>, <u>all over the US</u><sup>[14]</sup>, completing the most legally dangerous and expensive part of the journey.
